

SAS® Anti-Money Laundering 2.2

This Road Map briefly describes the media contained in your SAS Anti-Money Laundering 2.2 package and how to proceed to install the software.

Description of Your Package

Each installation kit in your package represents a distinct functional area of your solution. You should set these installation kits aside until the implementation team reads the *Solution Planning Guide*, which you can download from the SAS Anti-Money Laundering Resource Center at <http://support.sas.com/aml>. Please contact SAS Technical Support at <http://support.sas.com/techsup/contact/index.html> for the user name and password required to access the Resource Center.

Your SAS Anti-Money Laundering software comes in as many as two installation kits; each kit's contents should be installed on a separate machine:

- SAS Anti-Money Laundering Alert Generation Server
- SAS Anti-Money Laundering Discovery Client

SAS Anti-Money Laundering is a solution made up of the SAS Foundation, including several SAS products, and the files on the **SAS Anti-Money Laundering Investigation User Interface** and **SAS Anti-Money Laundering Supplemental Files** CDs.

How to Proceed

Step 1: Prepare for the installation.

- ☐ Go to the SAS Anti-Money Laundering Resource Center.
- ☐ Download and read the *Solution Planning Guide*. This document explains concepts, considerations, and preparation steps that are required before handling this software.

Step 2: Install and Configure SAS Anti-Money Laundering.

- ☐ To identify the installation kit that contains SAS Anti-Money Laundering Alert Generation Server, see the product listing on the SAS 9.1.3 label on each kit.
- ☐ Download the *Installation Manual* from the SAS Anti-Money Laundering Resource Center.
- ☐ Follow the instructions in the *Installation Manual* to install and configure SAS Anti-Money Laundering.

Step 3: Optional – Install the SAS Anti-Money Laundering Discovery Client.

- ❑ To identify the installation kit that contains SAS Anti-Money Laundering Discovery Client, see the product listing on the SAS 9.1.3 label on each kit.
- ❑ The SAS Anti-Money Laundering Discovery Client is optional software that includes SAS Enterprise Miner Client that you may use for data mining and advanced analysis. It may be installed on any Windows machine. If you choose to install the SAS Anti-Money Laundering Discovery Client, read and complete all of the steps in the *QuickStart Guide* of the SAS Anti-Money Laundering Discovery Client installation kit.

This installation kit also includes copies of the **System Requirements Wizard for SAS Enterprise Guide** CD and the **SAS Enterprise Guide** CD. This is optional software that you may use to enhance reporting. It may be installed on any Windows machine.
